Constitutional Law 275(1) Right to Work -- "Property" Right.

The right to work is property of which one cannot be deprived by simple mandate of the Legislator, but it is protected by the United States Constitution . . . and by numerous guaranties of the state Constitution, and the mere fact that it is also a part of the liberty of the People does not affect its character as property. [Ed. Note. For other cases, see Constitutional Law, Cent. Dig 830, 839, 843; Dec Dig 275(1)]
